AN ORDINANCE OF THE TOWN OF LAKE CITY, COLORADO FOR THE ANNEXATION OF LAKE CITY NORTH ADDITION NO. 2,

WHEREAS, a petition for the annexation of a tract of land known as LAKE CITY NORTH ADDITION NO. 2 has been submitted to the Town of Lake City and has been found by the Board of Trustees to be in substantial compliance with the requirements of the Municipal Annexation Act of 1965, as amended, including CRS 1973, 31-12-107 (1), as amended, and

WHEREAS, said petitions have been signed by the owners of 100 percent of the area proposed to be annexed, exclusive of streets and alleys, and

WHEREAS, the property is eligible for annexation in accordance with Municipal Annexation Act of 1965, as amended,

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF TOWN OF LAKE CITY, COLORADO AS FOLLOWS:

The following property known as the LAKE CITY NORTH ADDITION No. 2 hereby annexed to the Town of Lake City, Colorado.

TOWN PERIMETER DESCRIPTION:
